

Chapter 1 : Home ~ Children's Connections, Inc.

Online home study courses and programs are mainly designed for working adults who want to complete their studies from home. Occasionally, some courses or programs will require students to meet.

Essentially, a home study is performed to ensure that you would be capable and appropriate parents to an adopted child. Requirements of a typical home study in Vermont are as follows: Home Visits It will be necessary to have a Vermont certified Home Study Provider visit with you in your home to assess and qualify you for adoption. During these visits, they will be looking at the physical state of your home to ensure it is an appropriate environment for children. Having your home perfect is not essential – simple cleanliness and sanitation are most important as is insuring the home meets Vermont state housing codes, i. Interviews These typically take place in the home and usually during the home visits. The home study provider will meet with each individual living in the home to assess how well a new child will be received and accepted into the family. The interviews can be lengthy and involved as you will be asked about your background, how you were raised, hobbies, and numerous other questions focused on assessing each individual. Additionally, you will be asked to provide personal references that will be contacted and interviewed as well. When meeting with your home study provider, some of the discussion will focus on your adoption goals, specifically; the race, age, gender, etc. If you are open to a child requiring special needs – you and your families abilities to raise a child requiring these needs will be assessed as well. Your final home study will specifically state the characteristics of a child you are qualified to adopt. If you want to change these traits after your home study has been completed, you will be required to update your home study to verify that you are qualified. Dependent on the circumstances, a simple discussion with your home study provider will suffice for the documentation to be updated – other times; the social worker may deem it necessary to include additional steps or visits. Documentation Vermont requires that a criminal background investigation be performed. Know that if you have a past history, it does not necessarily mean that you will be unable to qualify for adoption. Typically, additional documentation and statements can be provided that will suffice any necessary requirements. Vermont further requires that each prospective adoptive family provide financial information and background. Your wealth is not important, however; your financial security and ability to be fiscally stable is. Tax returns, financial statements, pay stubs and income verifications are a few of the documents that may be requested during the home study process. Medical histories, both physical and mental will also be required. Often this will require a current physical and medical statement from the family doctor be provided by both potential adoptees. Also known as the Sex Offender Registration and Notification Act, this law allowed for the creation of a national sex offender registry. Many states are still in the process of integrating compliance with this law. As part of the home study process, you will be required to submit to a sex offender registry search. Once everything is completed and compiled, the home study provider will assemble the final home study report. Your completed home study will typically be required to initiate any process with an adoption agency. These are individuals that have proven to be professionals in their field. HOME STUDY. Louisiana Families may choose to independently provide an excellent education to their children from their home. Louisiana families typically provide this independent education through a Board of Elementary and Secondary Education approved home study program or a registered nonpublic school.

However, more often than not, agencies are looking for ways to rule families in rather than rule them out. Child Welfare Information Gateway has two publications that help explain the home study process: Home Study Requirements for Prospective Parents in Domestic Adoption , a fact sheet that summarizes state laws and policies regarding what information is collected Getting agreement among your family members to proceed Interviews done in association with the home study will be a self-reflective process where you may learn things about yourself and the dynamics of your family. If you have a spouse or partner, both joint and individual interviews are often part of the process, which may also include children who currently live with you or those who live outside the home. If you feel that you or members of your household are not yet ready for a home study, you can ask to delay this step. Being prepared for any associated home study costs Public agencies may charge an up-front, very low fee for adoption home studies. However, this fee is often reimbursable after you have adopted a child from foster care. This fee sometimes covers additional services such as an application fee and required training. Some or all of your out-of-pocket costs may be reimbursable if the services result in the finalized adoption of a child from foster care, so you should keep records and receipts of all of your expenditures. Be sure to discuss any fees thoroughly and ask for information in writing to avoid any misunderstandings. In general, even when you pay up-front, out-of-pocket fees to adopt from foster care, your expenses are ultimately reimbursed. If cost is a concern for you, find out more about family support resources that could be available to you if you adopt a child from foster care. Things to have or be prepared to get: A physical exam within the past 12 months is required for all prospective parents, and tuberculosis TB tests are required for every member of the household. However, a serious health problem that affects life expectancy might. If you have serious health problems, you may be required to think through or actually make a legal plan for assuring your adopted child will continue to be cared for in the unfortunate circumstance that you would die before they reach adulthood. Adults in the household may also need to obtain Federal Bureau of Investigation fingerprint checks and local police clearances under certain circumstances, such as recent relocation to the state where you currently reside. Applicants whose state or federal records indicate they have been convicted of harming children cannot adopt or foster. Some states may require a copy of an income tax form, a paycheck stub, or a W-2 form. Financial assistance in the form of subsidies is often available when adopting children from foster care. You will need to supply names, addresses, and phone numbers of three or four individuals who can attest to your experience with children, the stability of your current marriage or domestic partnership and household, and your emotional maturity. Most agencies require that references be people who are not related to you. Good choices might include close friends, an employer, a former teacher, a coworker, a neighbor, or a leader of your faith community. Many adoption agencies will ask each applicant to write an autobiographical statement or story. This is, essentially, the story of your life. It helps your caseworker understand your family better and assists them with writing your home study. Some agencies have workers available to assist you, and most will have a set of questions to guide you in writing your statement. Copies of legal documents. You will most likely be asked to provide copies of any applicable marriage licenses, birth certificates, divorce decrees, and other legal documents relevant to your application to foster or adopt. Depending on the agency you work with and the child you want to foster or adopt, this information could be shared with birth parents or others. If you have questions or concerns about the confidentiality of your information, verify with your agency how extensively it will be shared.
