An ambulance initially took me to a local hospital but I was soon transferred to Massachusetts General Hospital. A CT scan showed pieces of the vertebrae were touching the spinal cord. It was unclear what damage had been done to the spinal cord. I received in-patient care for over three months. The physical pain was muted by medication but the loss of independence and privacy was devastating. After my discharge, I had physical and occupational therapy for months. I resumed my normal activities after another six months. I still have back pain every day. I understand what my clients go through when they are injured in any way. I understand the indignity of not being self-sufficient and independent. I understand the frustration in not being able to work and to support yourself. It is important to hold people accountable for their mistakes. No one intends to rear end someone. Sometimes they do injure them because what they are doing has become too routine or because they were thinking about something else at the time they were treating that patient. No one intends for these injuries to happen but someone is hurt and her life is disrupted. The wrongdoer or negligent person must be held accountable for two reasons. First, the injured person must be compensated. My experience as an injured person helped me to understand what my clients are going through.
