You say in the book that you never informed on friends or associates. How did you regain your freedom? So we were all locked up at a federal prison, playing cards and still living the Mafia life. People would come for visits who were collecting money for us. I still had hijack loads that I had hidden and was selling. I still had a loan shark book on the street. So I was collecting money for the money that I had lent out. Somebody threw an apple at the guard, and it was dark and they thought it came from me in the dormitory. So down I went. You have to push your hands back up to the door, push your hands through the food slot, get hand cuffed and chained and then walk away from the door to be allowed out of the cell. So you really feel like an animal. What was your next step?
