Hallervorden was a brain specialist who was Chairman of the Special Pathology Section of the Kaiser Wilhelm Institute; he supported the autopsy of euthanized children for research purposes and dissected their brains himself. He ordered Nazi physicians to send him the brains from concentration camps, stating: Of course, I accepted the brains. Where they came from and how they got there was of no real interest to me. The fate of the "Hallervorden Collection" was not sealed until The Max Planck Institute finally admitted that the "historical material" stored in its basement was the harvest of Nazi euthanasia. The "material" was eventually given a burial at a Munich cemetery. Villinger also relied upon the guidelines of the Sterilization Act to justify sterilizing what he deemed to be "asocials. The methods used and personnel trained in the killing centers for the chronically sick became the nucleus of the much larger centers in the East, where the plan was to kill all Jews and Poles and to cut down the Russian population by 30%. They acted on their own. They were not carrying out a death sentence pronounced by someone else. They were the legislators who laid down the rules for deciding who was to die; they were the administrators who worked out the procedures, provided the patients and places, and decided the methods of killing; they pronounced a sentence of death in every individual case; they were the executioners who carried it out without being coerced to do so; they surrendered their patients to be killed in other institutions; they supervised and watched the slow deaths. When the giant extermination centers were set up in the east, a psychiatrist from the euthanasia program was one of the first commandants. Consultants from the euthanasia program helped set up these extermination camps and personnel from the program initially staffed them. Furthermore, the first systematic murders of concentration camp inmates took place in the euthanasia centers under the direction of teams of psychiatrists led by Werner Heyde. These laws were passed during the National Socialist Regime. But the ideas from which they arose are centuries old. In , he was declared unfit to stand trial. The next year he was sentenced to six years jail. Hallervorden was a brain specialist who was Chairman of the Special Pathology Section of the Kaiser Wilhelm Institute ; he supported the autopsy of euthanized children for research purposes and dissected their brains himself. He ordered Nazi physicians to send him the brains from concentration camps, stating: There was wonderful material among these brains, great mental illnesses, deformities and early childhood illnesses. Of course, I accepted the brains. Where they came from and how they got there was of no real interest to me. The fate of the "Hallervorden Collection" was not sealed until The Max Planck Institute finally admitted that the "historical material" stored in its basement was the harvest of Nazi euthanasia. The "material" was eventually given a burial at a Munich cemetery. Villinger also relied upon the guidelines of the Sterilization Act to justify sterilizing what he deemed to be "asocials. According to T4 staff member Meumann, "the registration forms that were processed by [Villinger] came back to us with considerable delays. After the war in , he went on to become a Professor and Director of the psychiatric clinic at the University of Marburg and became president of the GSPN in The Hamburg Medical Faculty described Villinger after as follows: Mauz was intimately involved in the development of the law for "ending the suffering" of the incurably ill. The final

session of the planning of this law took place in August, The final draft no longer exists, but is documented by a collection of several statements by the participants. The physicians involved were mostly concerned with finding an incontrovertible legal basis for euthanasia. Hitler rejected the draft and left it in a drawer. In the end, then, the psychiatric murders continued unhindered and outside of the law.

After trying and failing for two years to regain my equilibrium in civil life, I am utterly unable to approach anything like my own competence. My last physician informed me that it might be very helpful if I were to be examined and perhaps treated psychiatrically or even by a psychoanalyst. Toward the end of my service I avoided out of pride any mental examinations, hoping that time would balance a mind which I had every reason to suppose was seriously affected. I cannot account for nor rise above long periods of moroseness and suicidal inclinations, and have newly come to realize that I must first triumph above this before I can hope to rehabilitate myself at all. I cannot, myself, afford such treatment. Would you please help me? Hubbard later wrote of having observed a "Dr. The data was not utilized. This great pioneer, against the violent objections of medical doctors and the psychiatrists of his day, ventured to put forth the theory that memory was connected with present time behavior" [22] Hubbard elaborated: She gave Hubbard an ultimatum: He was furious and threatened to kill their daughter Alexis rather than let Northrup care for her. He thought I had thrown in with the psychiatrists, with the devils. Ron Hubbard kidnapped his wife Sara. Her allegations produced more lurid headlines: Because of his "crazy misconduct" she was in "hourly fear of both the life of herself and of her infant daughter, who she has not seen for two months". According to his estranged son Ronald DeWolf, Hubbard was under psychiatric care at this time. In his novel Battlefield Earth , the evil Catrists a pun on psychiatrists , are described as a group of charlatans claiming to be mental health experts. The Church of Scientology and psychiatry[edit] Scientologists often hold anti-psychiatry demonstrations A book, Believe What You Like , described an attempt by Scientologists to secretly infiltrate the National Association of Mental Health in Britain and turn official policy against mental health treatment. Though they were expelled from the organization after their identity and mission were revealed, the Church of Scientology then filed a number of suits against the NAMH. The Men Behind Hitler states: Scientology has attracted much attention through its propaganda effort against what it calls psychiatry. This has involved great expense and organizational effort, carried out through a variety of fronts. If the book Psychiatrists: Reading this book, and I will urge you not to waste too much time doing it, makes clear that the authors simply have no idea what psychiatry is. We have not responded in any way, shape or form. There has not been a hue and cry from members to respond. And anyway, the publication speaks for itself. In , a series of media reports examined the legal contracts required by Scientology, which require that, among other things, Scientology followers deny any and all psychiatric care that their doctors may prescribe to them: I do not believe in or subscribe to psychiatric labels for individuals. It is my strongly held religious belief that all mental problems are spiritual in nature and that there is no such thing as a mentally incompetent person â€” only those suffering from spiritual upset of one kind or another dramatized by an individual. I reject all psychiatric labels and intend for this Contract to clearly memorialize my desire to be helped exclusively through religious, spiritual means and not through any form of psychiatric treatment, specifically including involuntary commitment based on so-called lack of competence. Under no circumstances, at any time, do I wish to be denied my right to care from members of my religion to the exclusion of psychiatric care or psychiatric directed care, regardless of what any psychiatrist, medical person, designated member of the state or family member may assert supposedly on my behalf. In Hubbard declared all-out war on psychiatry, telling Scientologists that "We want at least one bad mark on every psychiatrist in England, a murder, an assault, or a rape or more than one. CCHR has also opened a permanent museum, " Psychiatry: An Industry of Death ", in Hollywood. The socio-political roots of the movements have different origins. Advocates of the anti-psychiatric world view such as David Cooper , R. Laing and Michel Foucault had ties with the political left of the s; Thomas Szasz , with the civil libertarians of the right, as well as an outspoken atheist. Many advocates of the anti-psychiatry movement have stated that they consider the idea of "mental illness" as a convenient and inaccurate label assigned by society rather than an objective biomedical state, rejecting psychiatric terms such as schizophrenia which they may see as stigmatizing. Thankfully, it was translated into English by Rolf and Sybil Rentmeister, whose names deserve to be mentioned considering the excellent quality of the translation. Like other historians writing on this subject around the middle of the previous decade, the authors explode the myth that the quest for racial purity started with Hitler. But they go one step farther, and also explode the myth that it ended with Hitler. The name, of course, has been changed, but the idea behind it remains. Students from all over the world came to learn at the feet of the professors who would become king pins in third reich atrocities. Some of those king pins were later executed, several more committed suicide. Most not only escaped punishment, often protected from prosecution by U. Furthermore, their students from across the world carried their teachings back to their own countries already before The Holocaust, and continue to do so to this very day. The mass murderers and their supporters are still considered authorities, and their works are widely quoted in current psychiatric professional literature. These psychiatrists were responsible for, among other things, LSD experiments on unwitting prisoners. In fact, the authors ascribe the origin of the drug culture which permeates developed societies to psychiatry. LSD, heroin, cocaine, and amphetamines were all first introduced by psychiatry, but leaked out into the general population, contributing to the violence of our societies. Also interesting is the psychiatric connection to the war in the former Yugoslavia. One surprising claim made by the authors is that by the fall of the third reich, over two million people had been compulsorily sterilized. Other historians place this figure at ,, most of those people later having been mass murdered. The authors provide no source for their figure, even though their book is otherwise well-researched. This probable exaggeration casts an undeserved shadow of incredibility over the rest of it. Rather than dwelling on the details of the horrors, the authors repeatedly point to the source of psychiatric power: Whether in the third reich, in the US, or in Bosnia, psychiatrists have always courted powerful politicians, permeated the military, and lobbied government. There is no reference at all to Scientology in the body of the book. The connection to Scientology no doubt keeps this excellent book off of academic library shelves and prevents its important message from receiving the attention it should.
